A Message from the CEO

Legislative Update

Perhaps I should stop reading the newspaper about the wonky activity in the Oklahoma state legislature. Every month it just seems to get more unreal. For example, the House leadership is unclear on its path with at least three plans being worked today: (1) bring back HB 1054 the "Grand Bargain"; (2) bring back the stand alone cigarette tax at \$1.50; or (3) cuts to agencies and use special cash and go home. Unfortunately, they opted for (3) only to have it vetoed by the Governor. Now they are back to the drawing board - and maybe there will be another special session. I am not holding my breath - so prepare for impact. According to the Oklahoma Hospital Association, it is estimated that MRHC will see an annual reduction of \$1.43 million in Medicaid payments to McAlester Regional. That's based on the cumulative percentage cuts hospitals have suffered since 2010. BTW – that is before another 9% cut as announced by the Health Care Authority yesterday to start December 1st. I estimate 9% equates to an additional \$1.5M reduction. Somehow however, I do believe our state leadership will get this solved by the time this is printed.

McAlester Regional Health Center or McAlester Regional Health System?

In my office are five old strategic plans dating back to the early 90's all

referencing the desire for MRHC to become a "Regional" hospital? It took a few decades, but I am convinced that our goal of becoming a Regional hospital is coming to fruition. For example, MRHC is the only level III Trauma Hospital and level-II stroke center within an hour's drive of any other capable facility; is building a new \$12M Emergency Center to service all the first responders of SE Oklahoma, has a robust Family Medicine rural residency program that is training future community doctors, created SEAN (SE Alliance Network), a collaborative of hospitals, clinics and community services, and has/will be opening new facilities in Eufaula, Wilburton and on the south side of McAlester. So that's it? I do not think so. My feeling is we will blast past becoming a Regional hospital and move quickly to becoming a "system" over the next two years. MRHC is now managing the Atoka County Medical Center, and is being asked to assist others. Our breadth and scale in helping other hospitals is gaining traction. We may find ourselves as a rural tertiary health system partnering or even managing other hospitals to the betterment of SE Oklahoma. Stay tuned.

Results will be mailed to your home and you are responsible to consult with your physician on the interpretation of the results. The deadline to use this free benefit is March 31, 2018.

Employee Wellness Program 2018


The 2017 Employee Wellness Program ended on a great note! The main point of the Employee Wellness Program is that covered employees and their covered spouses are aware of their current health status and have the tools that he or she needs to maintain or improve that health status. During 2017, there were 544 biometric screenings. This is 85% of our covered employees and spouses! The standard for the business is 53% for the second year of an employee wellness program. Thank you for participating! Overall, our health has improved in BMI, Blood pressure, Glucose and Overall Risk! You all have been working hard and it showed! So, what happens now? Now, you can start on the 2018 program. Biometric screenings are tentatively scheduled for June. Before then, you can start working to possibly improve your scores even more! You can do this by going to the MRHC Wellness Center. Remember, for every week you go at least three times a week, you get 5 points for that week up to 100 points for the year! You can have a coaching session and talk with a coach about different techniques to improve your health status on an individual basis. This is worth 30 points for a max of 120. You can also start scheduling your 2018 annual health screening with your PCP, your annual cancer screenings and your vision and dental appointments! Look for the first quarterly meetings coming up in late March!



W2s & 1095-Cs Available January 31, 2018

It's that time of year again! Tax time! W2s are your forms that show your income for 2017 as well as different tax reporting such as Federal Tax Withholdings, State Tax Withholdings, Foundation contributions, etc.... 1095-Cs are the Tax Forms that show your 2017 benefit elections and eligibility. These forms will be available January 31, 2018. You can access these forms via your ADP Self-Service Portal. If you do not know your user name and password, make sure you click "Forgot User Name and Password." You will need to input your name and either your email OR phone number tied to your ADP account. These forms will also be mailed. It is very important that you ensure that your address is up to date with HR. You can update your address via ADP Self-Service portal. If your W2 or 1095-C is returned to HR or payroll, we will place the envelope in the inter-office mailbox with a request for an address update. Please return the address update ASAP to HR so that we have the correct mailing address on file.
